## **TOWN MANAGERS REPORT – Mike Kehoe, Town Manager**

The Mayor said the Town Manager left no report but she reported that the Town was repairing the fire hydrant on Barley Dr. that had been hit by a car and during that repair, there were problems encountered. She added that water was turned off temporarily for repairs but all service was restored

## **COUNCIL COMMENTS/CALENDAR**

Council member Hollis said in reading the police report, he noticed that the calls for service went from 1604 to 3248-doubled. The Chief explained that a lot of the calls for service that were added in this report were not being counted before. He said more small calls like business checks and residential checks were being lost on the stats before. He said they were now reporting these smaller calls including lockouts for vehicles and houses. The Chief added that he had cut back on working traffic and all the officers were concentrating on more patrols for safety purposes. Council member Hollis thanked the Chief and his staff for the good work. Chief Bockey said the guys were doing a good job. The entire Council thanked the Chief.
